Website Design & Redesign Agreement

THIS AGREEMENT is made on the EXACT DAY whereas the COMPANY has purchased an on-site website design or website redesign product (One of our “Standard Startup Web Development”, “Custom Startup Web Development”, “My Online Store Web Development”, “Standard Redesign Web Development”, “Custom Redesign Web Development”, and “eCommerce Redesign Web Development” products).

BETWEEN:

Depeche Code Inc., the DEVELOPER

AND

The Purchasing COMPANY (Of one of our “Standard Startup Web Development”, “Custom Startup Web Development”, “My Online Store Web Development”, “Standard Redesign Web Development”, “Custom Redesign Web Development”, and “eCommerce Redesign Web Development” products)

Development Clause

Upon checkout of one of our “Standard Startup Web Development”, “Custom Startup Web Development”, “My Online Store Web Development”, “Standard Redesign Web Development”, “Custom Redesign Web Development”, and “eCommerce Redesign Web Development” products, this agreement is made and entered between Depeche Code Inc. (hereinafter “DEVELOPER”) and COMPANY in acceptance of this agreement.

This agreement is to help protect BOTH parties involved in the project. NOW, THEREFORE, for and in consideration of the mutual covenants contained herein and other good and valuable consideration, the

receipt and sufficiency of which is hereby acknowledged, COMPANY and DEVELOPER do hereby agree, covenant, and agree as follows:

- DEVELOPER hereby agrees to provide to COMPANY for the website services described on the specific product the COMPANY purchased. As well as any additional bonus (or bonuses) if given.
- COMPANY hereby agrees to compensate DEVELOPER for the amount listed on checkout on the Depeche Code website.
- COMPANY hereby agrees to compensate DEVELOPER for any remaining amount owed upon project delivery.
- DEVELOPER agrees it is not an employee of COMPANY for any purpose whatsoever.
- DEVELOPER agrees that it shall complete the work services within 4-8 weeks from projects first payment made. Times will vary depending on the size of the project, materials provided by the COMPANY like additional content, etc.
- COMPANY agrees to work with DEVELOPER regarding any requested revisions/changes to the website and vice versa. DEVELOPER agrees to hold the project to a high standard of visual/functional development and to TRY to over deliver on the completed product.
- No waiver of any provision of this Agreement shall be deemed, or shall be deemed, or shall constitute, a waiver of any other provision, whether or not similar, nor shall any waiver constitute a continuing waiver.
- All intellectual property created under this agreement remains the sole property of COMPANY.
- This agreement encompasses the entire agreement of the parties and there are no other agreements, oral or written.
- This agreement may not be modified or amended except in writing with the same degree of formality with which this agreement has been executed.
